TRADING SUSPENSION

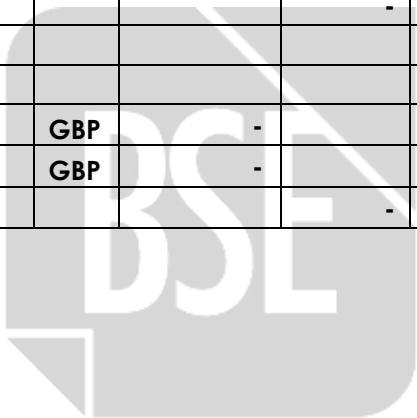
