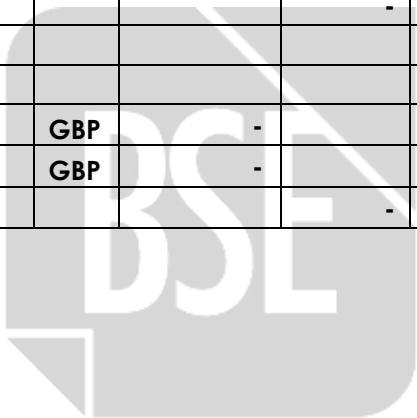
TRADING SUSPENSION
