Eppley Caribbean Property Fund SCC – Value Fund was the volume leader trading 17,839 shares at a high of \$0.55 and a low of \$0.50 before closing down four (\$0.04) cents at \$0.51. They were followed by Eppley Caribbean Property Fund SCC – Development Fund and CIBC Caribbean Bank Limited which traded 16,667 and 5,000 shares respectively.
