- (b) there has been a failure to comply with any of the Exchange Requirements;

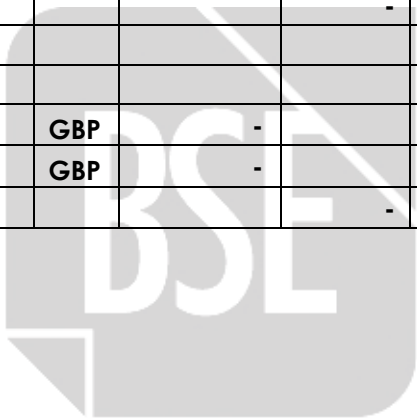
