Emera Deposit Receipt – Directors have fixed March 25th, 2026 as the record date for the determination of shareholders entitled to receive notice of the Annual General Meeting of the Company which will be held on May 21st, 2026.

DIVIDEND DECLARATION

Emera Deposit Receipt – Directors have declared a cash dividend of seventy-three point two five (CDN \$0.7325) cents per common share to be paid on **May 15th, 2026**, to Shareholders on record at close of business on **May 1st, 2026**.
