Three securities advanced and two declined as 582,873 shares traded on the Regular Market, with a total value of \$5,652,659.26. Goddard Enterprises Limited was the volume leader trading 479,938 shares at \$11.30 to close down ten (10) cents. They were followed by Sagicor Financial Corporation Limited and BICO Limited which traded 53,684 and 37,574 shares respectively.
