Two securities declined as 112,820 shares traded on the Regular Market, with a total value of \$301,367.58. FirstCaribbean International Bank was the volume leader trading 82,181 shares at a high of \$3.09 and a low of \$2.80 before closing down fifteen (15) cents at \$2.85. They were followed by Sagikor Financial Corporation Limited which traded 30,639 shares.
