One security advanced, two declined and two traded firm as 53,219 shares traded on the Regular Market, with a total value of \$123,193.75. Insurance Corporation of Barbados Limited was the volume leader trading 27,504 shares at a high of \$3.25 and a low of \$3.20 before closing up seventeen (17) cents at \$3.24. They were followed by Eppley Caribbean Property Fund SCC – Value Fund and Cave Shepherd and Company Limited which traded 20,000 and 2,500 shares respectively.

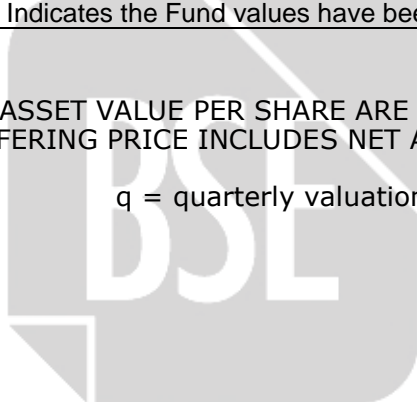

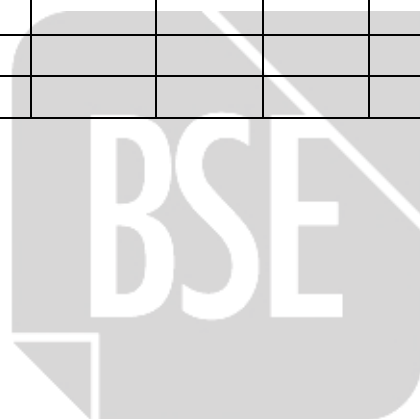
