Two securities declined and one traded firm as 2,065,455 shares traded on the Regular Market, with a total value of \$1,158,554.15. Eppley Caribbean Property Fund SCC – Value Fund was the volume leader trading 2,058,233 shares at a high of \$0.56 and a low of \$0.55 before closing firm at \$0.55. They were followed by Banks Holdings Limited and Barbados Farms Limited which traded 5,348 and 1,874 shares respectively.

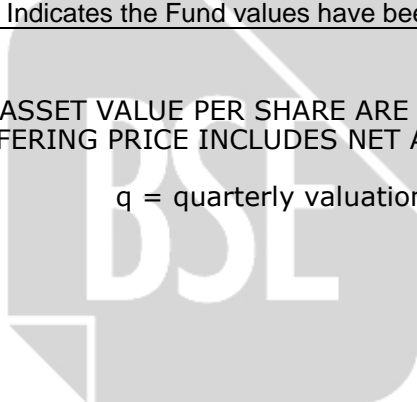
