One security advanced, one declined and four traded firm as 49,600 shares traded on the Regular Market, with a total value of \$154,642.93. FirstCaribbean International Bank was the volume leader trading 44,445 shares at a high of \$2.90 and a low of \$2.86 before closing down four (4) cents at \$2.86. They were followed by Goddard Enterprises Limited and Eppley Caribbean Property Fund SCC – Value Fund which traded 3,300 and 625 shares respectively.
