One security declined and two traded firm as 38,097 shares traded on the Regular Market, with a total value of \$95,102.44. Sagicor Financial Corporation Limited was the volume leader trading 17,597 shares at a high of \$2.92 and a low of \$2.91 before closing firm at \$2.92. They were followed by Goddard Enterprises Limited and Eppley Caribbean Property Fund SCC – Value Fund which traded 12,000 and 8,500 shares respectively.
