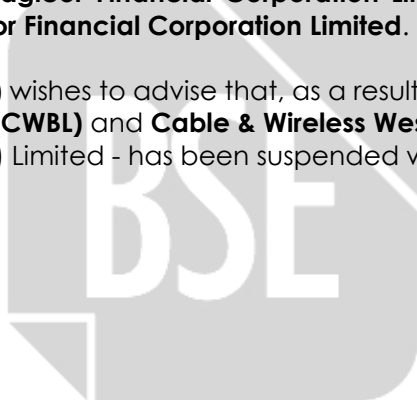
TRADING SUSPENSION
