TRADING SUSPENSION

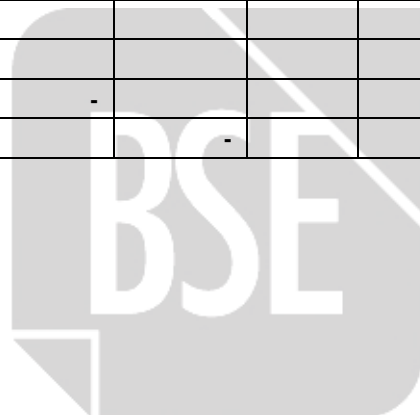
