## **TRADING SUSPENSION**

The **Barbados Stock Exchange Inc. 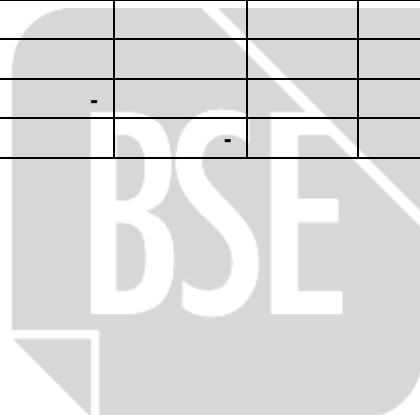
