Banks Holdings Limited suffered a 29% decrease in revenues compared to 2019 due to the Covid 19 pandemic, the resultant ban on the sale of alcohol and the removal of carbonated soft drink sales at the onset of the Joint Venture with Koscab in Nov 2019. This reduction in revenues coupled with an increase in taxation from deferred tax entries resulted in a 19% decline in Net Income of vs 2019.

In the face of the Covid 19 pandemic, the Banks Holdings Limited group remains committed to the safety and health of its employees, customers and stakeholders. The group will continue to operate within the Government's guidelines to ensure a continuous supply of our products to the market.
