#### TRADING SUSPENSION

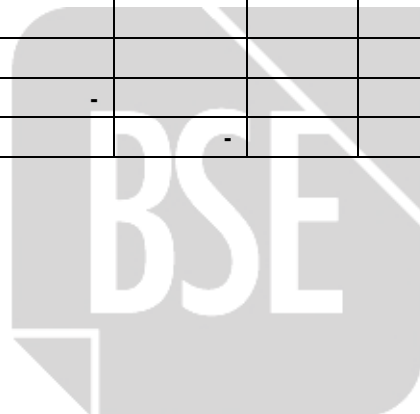
