TRADING SUSPENSION

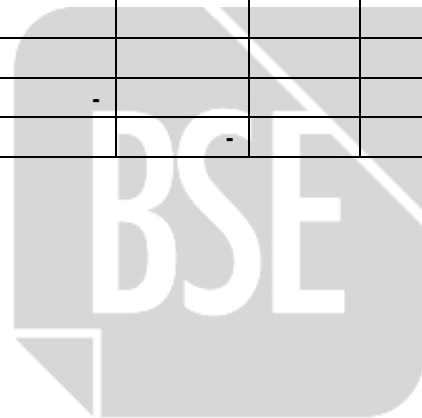
