### TRADING SUSPENSION

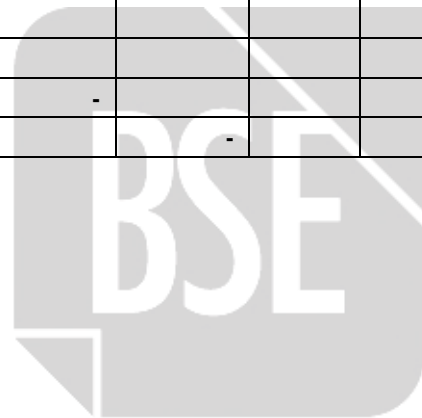
