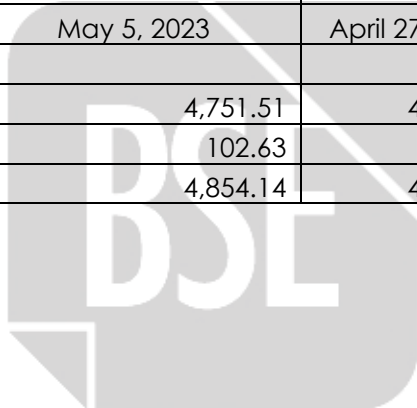
## Week in Review
